



Currently, 60.2% of the 53,565 housing units in the area are owner occupied; 29.9%, renter occupied; and 9.9% are vacant. Currently, in the U.S., 56.4% of the housing units in the area are owner occupied; 32.4% are renter occupied; and 11.2% are vacant. In 2010, there were 50,739 housing units in the area - 60.3% owner occupied, 29.9% renter occupied, and 9.9% vacant. The annual rate of change in housing units since 2010 is 2.44%. Median home value in the area is \$129,335, compared to a median home value of \$234,154 for the U.S. In five years, median value is projected to change by 2.38% annually to \$145,462.
